

RESOLUTION #14-2012/2013

WHEREAS: The Grundy County Board of Supervisors is empowered under authority of the Code of Iowa to impose weight limitations on highway structures under their jurisdiction.

NOW THEREFORE BE IT RESOLVED by the Grundy County Board of Supervisors that the following structures be posted at their listed load limits.

- Bridge located near W1/4 Corner, Sec. 28-89-17, Pleasant Valley Township, (C-26) - New Posting Load - 18 Ton
- Bridge located near N1/4 Corner, Sec. 33-89-17, Pleasant Valley Township, (C-31) - New Posting Load - 18 Ton
- Bridge located near N1/4 Corner, Sec. 18-89-18, German Township, (D-10) - New Posting Load - 422, 536, 634 Ton
- Bridge located near N1/4 Corner, Sec. 8-88-18, Shiloh Township, (E-08) - New Posting Load - 9 Ton
- Bridge located near NE Corner, Sec. 06-88-17, Colfax Township (F-04) - New Posting Load - 422, 536, 634 Ton
- Bridge located near N1/4 Corner, Sec. 18-88-16, Lincoln Township (H-10) - New Posting Load - 10 Ton
- Bridge located near NW Corner, Sec. 02-87-15, Blackhawk Township (I-01) - New Posting Load - 12 Ton
- Bridge located near W1/4 Corner, Sec. 14-87-16, Washington Township (J-13) - New Posting Load - 10 Ton
- Bridge located near W1/4 Corner, Sec. 35-87-17, Palermo Township (K-12) - New Posting Load - 422, 535, 639 Ton
- Bridge located near N1/4 Corner, Sec. 15-86-18, Felix Township (M-10) - New Posting Load - 10 Ton
- Bridge located near NE Corner, Sec. 11-86-17, Clay Township (N-07) - New Posting Load - 12 Ton
- Bridge located near SW Corner, Sec. 36-86-17, Clay Township (N-25) - New Posting Load - 9 Ton

AND the following structures previously restricted load limits have been removed due to repair or replacement:

- Bridge located near NW Corner Sec. 18-89-18, German Township, (D-12) - New Posting - Legal
- Bridge located near N1/4 Corner Sec. 12-87-15, Blackhawk Township, (I-04) - New Posting - Legal
- Bridge located near SW Corner Sec. 15-88-18, Shiloh Township, (E-16) - New Posting - Legal
