NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Grundy County, lowa as follows:

Section 1: The amounts itemized by fund and by department or office on the schedule below.

Section 2: Subject to the provisions of other county procedures, regulations, and applicable state law, the appropriations authorized under Section 1 shall constitute authorization for the department or officer listed to make expenditures or incur obligations from the itemized fund, effective July 1, 2016.

Section 3: In accordance with Section 33.1 437 of the Code of lows, no department or officer shall expend or contract to expend any money or incur any liability, or enter into any contract which by its terms involves the expenditure of money by one process of amounts appropriated pursuant to this resolution.

Section 5: If a dary time during the 2016-2017/budget year the Auditor shall ascertain that the available report of that year will be less than said fund's total appropriation, she shall immediately so inform the Board and recommend appropriate corrective action.

Section 5: The Auditor shall establish separate accounts for the appropriations authorized in Section 1, each of which shall indicate the amount of the appropriation, the amount charged thereto, and the unencumbered balance. The Auditor shall report the status of such accounts to the applicable departments and officers Section 6: All appropriations authorized pursuant to this resolution lapse at the close of business on June 30, 2017.
